Trustee's Notice to Registered Preferential Shareholders on Stage One Redemptions Regarding Extension of the Wallet Registration Window

The undersigned, as Trustee of CCS Liquidation Trust Inc. (jointly referred to as "the SPV" or "the Trust"), hereby notifies the registered preferential shareholders of the Trust who are subscribed to Stage One of the redemptions that, in light of the current deadline for the wallet submission process and in consideration of multiple extension requests submitted by shareholders, the undersigned has authorized an extension of the wallet registration deadline. Therefore, the deadline for wallet registration via the wallet verification system is now extended to January 26th 2026 in consideration of the upcoming closure of operations during holidays

Shareholders are advised that those who do not actively upload their wallets within the specified timeframe, including those who are unreachable via their registered email, will be moved to a non-active shareholder registry. Consequently, their shares will be removed from the current Stage One Register. Redemption may be then permitted subject to the limitations defined in Section 6 - XI of the Trust's previously published report.

If a shareholder has not received the relevant instruction email from the Trustee and hold valid, non-suspended shares or active rights, they are advised to contact the Trustee immediately at trustee@universum.icu for verification.

Shareholders are hereby requested again to carefully and thoroughly review the provided guides and processes to ensure accuracy and completeness, allowing sufficient time to complete all requirements in order to preclude the necessity of further extending the registration period. Shareholders are also reminded that the capital for an initial distribution is very limited. However, this system may be employed repeatedly and automatically to manage future payments if additional capital becomes available, thereby streamlining and improving these operations.

The Trustee hereby reminds all shareholders that neither the Trustee nor any committee or administrative body of the Trust will ever solicit or request private keys under any circumstances. Should any request for private keys be received from any party, shareholders are urged to report such incidents immediately to the Trustee.
